The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 11 26 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Self Injection: Accidental self injection may lead to an inflammatory response. Medical advice should be sought on the management of deep injections, particularly those near a joint or associated with bruising. If possible the application of gentle squeezing pressure with absorbent material (e.g. facial tissues) at the injection site will swab up unabsorbed vaccine. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied. Check your tetanus immunisation status.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Gently blot away excess liquid. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed. If irritation or symptoms occur or persist, consult a physician.

Eye Contact: Quickly and gently blot material from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses. If irritation or symptoms occur or persist, consult a physician.

Ingestion: If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

NOTE TO PHYSICIAN: Vomiting is contraindicated due to the possibility of aspiration pneumonia. This product is a vaccine. Accidental injection may cause irritation and swelling. This vaccine contains non-degradable mineral oil; the deposited vaccine must be completely drained from the injection site immediately. If left untreated it may cause tissue necrosis. This preparation contains a preservative or antibiotic or both which may cause allergic reactions in susceptible individuals.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Storage: Protect this product from light. Store in the closed original container in a dry, cool (2-7°C), well-ventilated area out of direct sunlight. Section 10 - Stability and Reactivity

Reactivity: This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

Conditions to Avoid: Protect this product from light and heat. Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight.

Incompatibilities: strong oxidising agents.

Fire Decomposition: No specific data. Based on composition of proteins and fats, the following might be expected: Carbon dioxide, and if combustion is incomplete, carbon monoxide and possibly smoke. Nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Oxides of sulfur (sulfur dioxide is a respiratory hazard) and other sulfur compounds; also water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Emergency Overview

Physical Description & Colour: White to off-white opaque oily liquid.

Odour: No data.

Major Health Hazards: no significant risk factors have been found for this product.

Potential Health Effects

This product is a vaccine for use in animals. This vaccine is not pathogenic to humans or animals. Local irritation to the eyes, skin, or respiratory tract may occur following direct contact or inhalation of the lyophilized product. As with any vaccine, exposure may cause hypersensitivity reactions. Accidental injection may cause local swelling, irritation or necrosis at the injection site. Oral ingestion may cause gastrointestinal effects including nausea, vomiting, and diarrhoea. Ingestion of mineral oil may cause laxative effect, nausea, dehydration or lipid pneumonia. Long-term dermal exposure to mineral oil may cause dermatitis and oil acne.

Inhalation:

Short Term Exposure: Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term Exposure: No data for health effects associated with long term inhalation.

Skin Contact:

Short Term Exposure: Available data indicates that this product is not harmful. It should present no hazards in normal use. In addition product is unlikely to cause any discomfort in normal use.
