## DIRECTIONS FOR USE

### Contraindications:

This product is contraindicated in lambs under 8 weeks old.

### DOSAGE AND ADMINISTRATION:

#### Precautions:

**Important: Do not use excessive force when dosing in order to avoid trauma and damage to the throat of the animal.**

Sheep all ages — 1 pellet every 3 years.

#### Preventive treatment:

Adult sheep — Dose as soon as convenient. Repeat dose on veterinary advice.

Young sheep — Dose as soon as convenient after 8 weeks of age.

#### Corrective treatment:

Sheep all ages — Dose immediately. Repeat dose on veterinary advice.

**WITHHOLDING PERIOD: Zero (0) Days.**

### TRADE ADVICE:

EXPORT SLAUGHTER INTERVAL (ESI): Zero (0) Days.

### GENERAL DIRECTIONS:

To be effective the pellet must be swallowed. It is recommended that pellets be administered using the Coopers® Sheep Pellet Applicator. It is important to carefully read the applicator use instruction leaflet enclosed in container before use.

It is recommended that a steel grinder be administered when treating sheep with the combination of PERMATRACE pellets outlined in the table below. This will keep the surface of the cobalt pellet clean and active by preventing a coating building up on the surface of the pellet. Steel grinders are available from Coopers Animal Health.
